



REGULATIONS

for visitor conduct on all BBT SE open-air construction sites and tunnel construction sites

Please **understand that due to ongoing construction work we can only admit visitors to tours of open-air construction sites and/or tunnel construction sites** (*hereinafter referred to as "construction site tour"*) if each visitor has expressly confirmed to us that they accept and will comply with these Visitor Regulations.

Conditions of participation:

- ❖ Visits to construction sites are at the **visitor's own risk**.
- ❖ Persons who are **under the influence of alcohol** or whose obvious behaviour indicates that they are **incapable of understanding the dangers of a construction site and of construction site traffic** and of behaving in accordance with this understanding may NOT participate in the construction site tour.
- ❖ **Children and young people under the age of 18** are also NOT allowed to take part in the site visit, except for young people over the age of 15 who must present a declaration of consent from their legal guardian and be accompanied by a responsible adult supervisor (teacher, etc.).
- ❖ **Physical fitness** is an essential prerequisite for the participation. Persons who require walking aids are unfortunately not allowed to participate in the construction site tour.
- ❖ **Pregnant women and persons with pacemakers** are strongly advised not to take part in the site visit for health reasons (dust exposure, vibrations due to blasting, ...).

Protective clothing:

- ❖ Wearing the **protective equipment** provided to visitors (hard hat and protective vest with luminous stripes; for tunnel tours protective boots, too) is mandatory **for the entire duration of the construction site tour**. If needed, visitors will also be provided with ear protection.
- ❖ If the construction site tour also includes a tunnel tour, visitors are obliged to wear the detection tag (personnel location device) provided to them **during the entire duration of the construction site tour**.
- ❖ If a tunnel tour is also included in the site visit, each visitor will receive **safety instructions on the use of the oxygen self-rescuer**. One such oxygen self-rescuer per visitor is carried in the transport vehicle and must be put into operation in the event of danger on the instructions of the guide.

The protective equipment provided as well as the detection tag are to be returned by the visitor after the end of the site visit; in the event of loss or damage, a replacement is to be provided. **In case of loss or damage of the detection tag, visitors must pay a compensatory amount of Euro 70.00 in any case.**



Code of conduct during the construction site tour:

- ❖ **Smoking and alcohol consumption** are absolutely prohibited.
- ❖ **Protective equipment** and, if necessary, a **detection tag** must be worn throughout.
- ❖ Construction site tours **are only permitted under the guidance of employees of BBT SE, ÖBA** (local construction supervision) or ARGE (executing construction companies).
- ❖ The **instructions of the guides** must be **followed** immediately and to the letter; this also applies to hand signals if understanding speech is difficult or impossible due to construction site noise.
- ❖ The transport vehicle may only be left with the permission of the guide.
- ❖ Visitors must remain in the group, it is **forbidden to leave the group**.
- ❖ **It is forbidden to stop or linger:**
 - within the operation or danger zone of vehicles, machines or tools;
 - behind vehicles, machines or tools;
 - near spoil transport vehicles being loaded
 - in an unsecured or newly secured tunnel area (rockface = current excavation area);
 - in loops or piles of cables, tubing and piping.
- ❖ When walking, always **pay attention** to the **ground conditions** and any **obstacles**.
- ❖ **It is forbidden to touch or enter vehicles, machines and devices, construction material, tools and electric and electronic facilities and devices.**

- a) they have received **safety instructions on the use of the oxygen self-rescuer**,
- b) they got a **safety instruction session on the handling of the oxygen breathing apparatus**,
- c) they have understood and accept the visitor regulations,
- d) they **obligate themselves to comply to the visitor regulations**,
- e) they participate in the **construction site tour at their own risk**,
- f) they assume liability for all property damage and personal injury caused by them as a result of the non-compliance to the visitor regulations,
- g) they **agree to the use of their personal data collected** for the purpose of participating in the construction site tour.
